Dear Shareholder,

We are pleased to be writing to you, as Directors of the Board of APS Funds SICAV plc (the "Company"), with details of the Twelfth Annual General Meeting to be convened on Thursday, 1st October 2020 at 11.00 am (the 'AGM'). Given we find ourselves in unprecedented times this year, in the grip of a pandemic, authorities are advising against attendance to large gathering events. The issue of Legal Notice 288 of 2020 has also made it possible for Annual General Meetings to be held remotely.

The Board has been closely monitoring the situation and in order to safeguard the wellbeing of the Company's shareholders, it has decided that the AGM proceedings be held remotely, and shareholders advised not to attend the AGM in person.

The Board appreciates that the AGM is one of the keyways we communicate with shareholders. It is an important opportunity for you to express your views by raising questions and voting, and over the past years, attending.

Therefore, we would still like to offer this opportunity to you, and together with this introductory letter we enclose the notice of AGM and a proxy form to enable you to exercise your voting rights. **The proxy form has been amended to permit voting authority to be granted to the Chairman only. The Board encourages shareholders to exercise their voting rights by submitting this form of proxy in line with the instructions provided on the form itself.**

Furthermore, arrangements for shareholders to be involved have been made as follows:

1. Shareholders are invited to send out any questions which are pertinent and related to the items on the Agenda of the AGM in advance, on email address info@apsfunds.com.mt, with the subject line "AGM 2020", or by a letter addressed to the Board of Directors, APS Funds SICAV plc, APS Centre, Tower Street, B'Kara BKR4012 by not later than noon of Tuesday 29th September 2020. The questions and replies will be posted on the website www.apsfunds.com.mt, by not later than noon of Saturday 3rd October 2020.
2. Shareholders are invited to follow the Chairman's speech on www.apsfunds.com.mt that will be available as from the 1st October 2020 from 11am, for a period of 30 days. An overview of the performance of the APS Income Fund, of the APS Regular Income Ethical Fund and of the APS Diversified Bond Fund, coupled with developments in the Maltese and international markets, particularly as a result of the pandemic, will also be given.

Lastly, the Annual Report and Accounts for the year ended 31 December 2019 are available on our website at www.apsfunds.com.mt, and have also been published on the Malta Stock Exchange on 23 March 2020. Copies are also available from APS Bank branches.

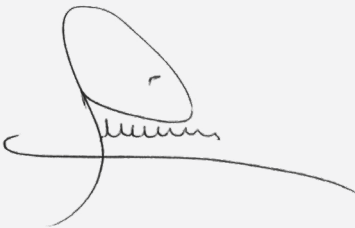
Barra minn hekk, għamilna dawn l-arranġamenti biex l-azzjonisti jkunu involuti fil-Laqgħa:
